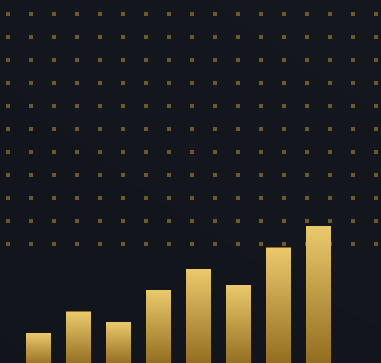

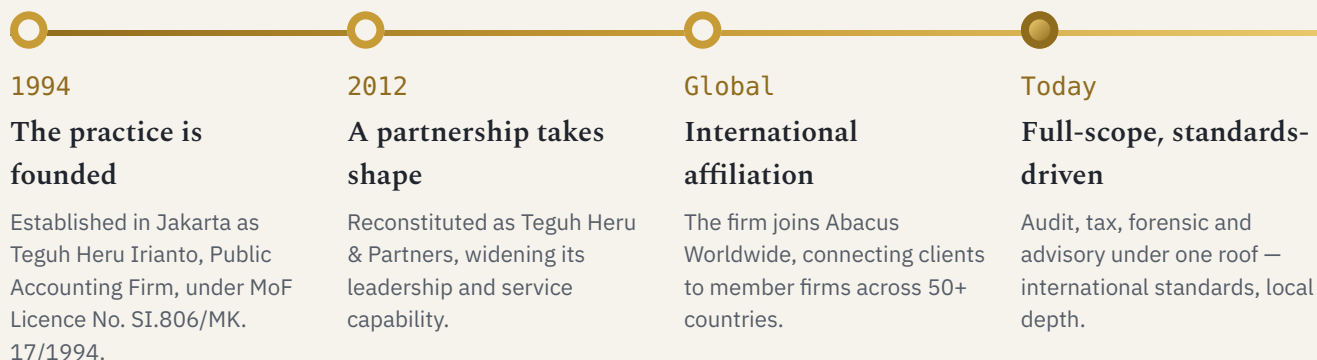
A public accounting firm with a *thirty-year record* and a global network behind it.

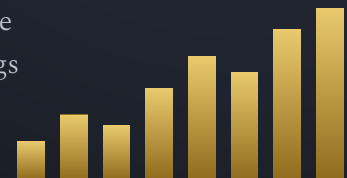

OUR FOUNDING DISCIPLINE

An opinion is only as good as the work behind it.

Every audit we sign is built on a risk-based methodology aligned to the International Standards on Auditing, documented from planning through to the file that supports our report. We audit to understand the business first and test the numbers second — which is why our findings tend to be useful long after the report is filed.



ENGAGEMENTS

- **General (statutory) audit** of financial statements for corporates, groups and foundations.
- **Special-purpose & compliance audits** — grant, project, and regulatory-mandated reporting.
- **Review engagements** (ISRE 2400) for entities needing limited assurance.
- **Agreed-upon procedures** (ISRS 4410-related) for targeted, factual reporting.
- **Group audits** coordinating component work across locations and, via Abacus, across borders.

WHAT SETS THE WORK APART

- **Scalable rigour.** We apply the ISA for Less Complex Entities framework where it fits — full assurance, proportionate effort.
- **Partner-led files.** A partner reviews the judgements, not just the sign-off page.
- **Digital workpapers.** A cloud-based audit platform keeps evidence, review notes and standards linkage in one auditable trail.
- **Data-driven testing.** Analytics let us look across whole populations, not only samples.

Methodology & Technology

07 / HOW WE WORK

A disciplined, risk-based approach — carried by a *modern digital platform*, so rigour and efficiency reinforce each other.

01

Understand

We learn the business, its environment and its risks before we test anything — the entity, its industry, its controls, and where its numbers are most exposed to error or judgement.

02

Assess & plan

Risks are identified and ranked, materiality is set, and the engagement is scoped so effort concentrates where it changes the answer. The ISA for LCE framework lets us keep that effort proportionate.

03

Test & analyse

Controls and balances are tested with a blend of substantive procedures and data analytics — examining full populations where the data allows, so exceptions surface rather than hide in a sample.

04

Conclude & review

Findings are evaluated, judgements are documented, and a partner reviews the substance of the file before any report is signed.

05

Report & advise

We deliver the opinion — and the observations behind it, in a management letter written to be acted on, not filed away.
